

The D2 group now has \$10,000 to improve housing. Diller Fire and Rescue will be purchasing extraction equipment with their \$7,800 award. The Diller-Odell Art Department will expand their pottery program and STEM club members will experience the science of Disney with DCFF support. The past and future of the community also received funding. The Bank Museum, Main Street plants, and eight youth programs were awarded a total of \$8,200 in grants.

The Diller-Odell Art and STEM Clubs provided a noon potato bar meal in conjunction wit the event. The free-will donation gleaned \$1,200 to help cover travel costs for their upcoming enrichment trips.

# Present Bias (cont'd from cover)

Every day, we make dozens of decisions. Many involve choosing between something with immediate results or delayed results. Having "present bias" means you have a tendency to prioritize the "here and now" benefits over the long term benefits (in turn, choosing the short term costs over the long term costs). This "present bias" way of making decisions becomes a "habit" and is soon ruling our lives, without us 3. even being aware of. What we are actually allowing to happen in our minds is called "cognitive economy", which means we are saving thinking time, which makes our decision making easier, and quicker. Because stopping to weigh the costs/benefits for the future takes more time and thinking, so we just don't do it, making ourselves feel better by making a "quick decision". It is also allowing us to have that "instant" feeling of gratification, instead of seeing that the gratification may come in the future. We are falling into the trap that so many have fallen into in our society—the instantaneous feeling of "that was easy, so it must be good" We are selling ourselves and our minds short here. However, this is something we can change. Once you are aware you are falling into the "present bias" trap, you can take steps against it. Here are reasons you should:

- I. YOUR PHYSICAL HEALTH: Present Bias often plays a big role in why we eat, drink, smoke, ingest substances, or do these in excess amounts. Because we aren't thinking of the future consequences. We are in the "now". The short term benefits of eating too much of an unhealthy item is that is "tastes so good" or "makes us happy for a few seconds". Making that snap decision favors the present, while thinking about the future isn't automatic—it requires more deliberate thinking and self discipline.
- 2. MENTAL HEALTH: "the snap decision to "yell at a student" or "yell at your child" feels good in the moment—it lets you release your frustration with them. However, if you take a second to think

- about the "long term" effects this might have on this child and their mental health, you may see it is not a good choice. It is good for you "right now", but not for them in the future. Your quick choices, may have long term consequences for them. If you are "quick to anger" or "lose your temper", you have falling into the present bias and aren't practicing self-discipline.
- 3. FINANCIAL HEALTH: We all know that financial security depends highly on playing "the long game". Not making quick spending decisions because they make you feel good for a few seconds, instead stopping and thinking about how that is effecting your future security may be a hard pill for some of us to swallow (myself included), and a hard habit to break, but like any bad habit, it needs to be broken.
- **ENVIORNMENTAL PROBLEMS:** Most of you know that I harp on this issue a lot. The environment is one area that I personally do not fall under present bias in. However, because of how the world is "politically" divided now, this is one of the issues that gets laughed at by a lot of people and brushed aside. If you are doing this you have fallen into the "present bias" trap. You may have told yourself "that's silly or not true" because you have heard it repeated over and over by certain groups. You have let yourself get trapped by making the decision to "write it off". You have taken the easy way out, a way where you don't need to stop and think about what you are doing today and how the future will be affected...another present bias to be picked up because it is easy and give you instant gratification. Here are some examples of present bias decisions you may be making that you could easily stop and think about the future, and make a better choice:
- —taking a long shower because it feels so good.
  - —using plastic bags at the store be-

cause you don't' want to take the time to grab or think about reusable totes.

- —using single use batteries instead of rechargeable because they are cheaper "now" and easier to just "toss" instead of charging.
- —toss plastic because then it is out of your mind and thinking space instead of dumping liquid out, rinsing and recycling.
- —using paper napkins and paper towels instead of fabric ones you can wash and reuse, because it's easier, quicker, and out of your mind and time. And quite frankly you may think something like this is "weird" and something you have never even thought about.
- —bought a quick, cheap piece of clothing (or fast fashion) because it "costs less right now" and is the most recent trend,. Instead of investing in high quality, sensibly made, pieces of clothing that will last you a long time and in the end, cost LESS.

(if you are making most of the above choices you have fallen into what is called "garbage can decision-making) Although some of "present bias" decision making is based on self-discipline and habits, it also can be affected by individual differences. Some people are higher in what's called "need for cognition". They like thinking hard and rationally. They favor deliberate judgement and decision making. Other people do not so much. They find thinking burdensome and hard. Also some of us are just more impulsive by nature and have a hard time delaying gratification.

When scientists and psychologists study these things and point them out to us, it is not to make us all feel like "big dummies", it is to make us become more aware of our tendencies and see ways to improve ourselves. To make us realize there are times when "thinking fast" is the right decision, but many times when "thinking slow" is the better choice. Balance is key, but we must make changes, that is if we care at all about our future generations. (maybe you have made the "present bias" decision to not read this article because it make take too much time and too much thinking:)

# <u>Diller-Odell Board of Education</u> Elementary Media Center-Diller December 11, 2023

Regular Board Meeting—7:00 pm Present: Adam Engelman, Paul Kostal, Kolin Kotas, Angie Clifford, Dusty Duis & Kasey Murphy.

Public comment was received from Matt Duis and Kayla Schnuelle on trying to establish more collaboration between youth sports and the school for the betterment of our school's students. Motion to approve minutes of last meeting made by Angie Clifford seconded by Adam Engelman. Passed with 6 yea, 0 nay. Principal Mezger provided an update on MAPS testing, Special Programs, the NASB conference and the State Principal Conference.

Ashley Duis provided an a report on student activities. Congratulations to all athletes earning post-season honors in Fall sports, students in One Act that placed third in districts, those students with success in Ag contests and especially to Dave Parde who participated in the National FFA Band last month. Motion to review and take possible action on grade scale for grades 7-12 which would revise policy 5078 and 5080 made by Kolin Kotas and seconded by Kasey Murphy. Motion passed with 6 yea, 0 nay. After researching other area schools' grade scales, the Board wanted to adapt the grade sale to be more comparable. The change will be as follows for grades 7-12: 93-100 A, 90-92 B+, 86-89 B, 84-85 C+, 78-83 C, 76-77 D+, 70-75 D, Below 69.5 F. The change will go into effect at semester and will change current student GPA's at that time. GPA would be calculated as: 4.0 A, 3.5 B+, 3.0 B, 2.5 C+, 2.0 C, 1.5 D+,

Motion to approve the Art trip to Chicago made by Angie Clifford and seconded by Adam Engelman. Motion passed with 6 yea, 0 nay. Superintendent Meyerle thanks Mrs. Klaus for her willingness to take students on the trip to experience downtown Chicago.

Discussion ending boys golf cooperative with Southern HS after the spring of 2024 to pursue a cooperative with Beatrice HS in baseball for the Spring of 2025. The Board plans to direct Superintendent Meyerle to write a letter to the NSAA Board to request that the Boys 2 year gold coop with Southern Public Schools be dissolved after the

2024 season. Dr. Prososki of Southern will also provide a letter to the NSAA. The NSAA Board would then need to approve of the dissolution of the program after the 2024 season. The existence of the golf program at Southern is not dependent on the cooperative, as golf can be offered with very few participants. The Board appreciates the opportunity of participating in the golf coop with Southern over the years, but now more students would be interested in playing baseball. Beatrice is receptive to the cooperative in basketball beginning in the spring of 2025. Superintendent Meyerle noted that if a cooperative was signed with Beatrice, that Diller-Odell would be joining the Beatrice baseball team. There would not be a new team name, new mascot, etc.

Superintendent Meyerle reported on a planned staff reassignment for 2024-2025. Mr. Hinrichs will move from the position of 6th grade teacher to PK-6 Principal. In times that see an increase in concerns with student behavior and school safety, the Board, Mr. Mezger, and Superintendent Meyerle agree that we need more eyes on student behavioral issues in each building. This change will see Mr. Hinrichs at the elementary full time as PK-6 Principal, and Mr. Mezger at the junior-senior high school full time as the grade 7-12 Principal. This change will allow Mr. Hinrichs and Mr. Mezger to deal with discipline and student behavioral issues at the respective buildings in a timely manner. Superintendent Meyerle, Principal Mezger, and the Board firmly believe this change will make our school stronger.

Diller-Odell Public Schools began the merger in 2000-2001 with three administrators, and cut back to two when on a levy over-ride. Most systems that have a two-site situation as Diller-Odell, have three administrators. Diller-Odell has done it with two for 17 years. The Board, Principal Mezger, and Superintendent Meyerle all recognize that life has changed in many ways over the years when dealing with student discipline and safety. In the need to address issues in a prudent manner, the reassigning of duties has been endorsed.

Superintendent Meyerle noted that the 2022-2023 Annual Report would be available next week. He reported that he had advertised for a 6th grade teaching position/Assistant Football Coach. With Mr. Hinrichs moving to a Principal

position, he would no longer be an Assistant Football Coach. He would continue as Head Boys Basketball Coach. Superintendent Meyerle reported on a recent meeting at he ESU with Senators Brandt and Dorn. Kasey Murphy also attended the meeting. School Finance was a topic of discussion at the meeting. Some schools in the state did not drop their tax request as many in the legislature had hope for 2023-2024. Superintendent Meyerle noted that all schools are different and in different situations. Thankfully, Diller-Odell was able to reduce the tax request for 2023-2024 and drop the levy by 7 cents in large part due to more of a financial commitment from the state.

Superintendent Meyerle always has concerns over how the state legislature views local control. Meaning, he believes the legislature likes local control (Boards), as long as Boards do what the legislature wants, the legislature then attempts to create legislation to control local Boards. Again, all schools are different, and local Boards know best how to run the schools in their respective

Motion to approve bills as presented made by Dusty Duis and seconded by Kasey Murphy. Motion passed with 6 yea and 0 nay.

The Board reviewed Superintendent Meyerle's contract. The contract will roll over until June 30, 2026 Motion to approve Policy 3055 School Resource Officer made by Kasey Murphy and seconded by Adam Engelman. Motion passed with 6 yea, 0 nay.

The School Resource Officer will serve Diller-Odell, Freeman, and Southern Public Schools. The officer will begin serving the schools sometime in early 2024. The coast is totally paid for by Gage County in year one. The officer will also serve our elementary school even though it is in Jefferson County. The officer's schedule is to be determined. The goal of this program is to build positive relationships with students and be a contact when such service is necessary with negative behavior

(bullying etc.) or attendance. Superintendent Meyerle provided his Board Committee recommendations for 2024. The Board will review and approve the assignments at the January meeting.

Motion to adjourn made by Adam Engelman and seconded by Dusty Duis.

# Diller-Odell Board of Education Elementary Media Center-Diller Wednesday, January 10, 2024 Regular Board Meeting—7:00 pm

Present: Adam Engelman, Paul Kostal, Kolin Kotas, Dusty Duis & Kasey Murphy. The absence of Angie Clifford was excused.

Superintendent Meyerle had an Oath of Office for each Board member to sign. Angie, Clifford, who was absent signed her Oath prior to the meeting. Motion to approve minutes of last meeting made by Adam Engelman seconded by Kolin Kotas. Passed with 5 yea, 0 nay. Motion to retain Board offices with Paul Kostal as President, Adam Engelman as vice President, and Angie Clifford as Secretary/Treasurer made by Adam Engelman and seconded by Kasey Murphy. Motion passed with 5 yea, 0 nay. Motion to approve committee appointments made by Dusty Duis and seconded by Kasey Murphy. Motion passed with 5 yea, 0 nay.

Motion to retain the Fairbury Journal News as the official newspaper, KSB School Law as legal representation, the State Bank of Odell as the official repository, and to appoint Superintendent Meyerle as the Attendance Officer and Federal Programs Director made by Kolin Kotas and seconded by Adam Engelman. Motion passed with 5 yea, 0 nay.

Motion to approve interlocal agreement with Gage County for SRD made by

Adam Engelman and seconded by Kasey Murphy. Motion passed with 5 yea, 0 nay.

The Board appreciates the efforts by Gage County in beginning the SRD Program. It will be a great benefit to the school in building positive relationships with law enforcement while being a quick response to issues such as truancy, bullying, and other matters of concern. Investigator Hanson, Sheriff Gustafson, and Deputy Hager were in attendance to introduce themselves to the Board. Deputy Hager looks forward to the working relationship as SRD with our elementary and high school.

No student report

The Board reviewed Principal Mezger's written report. Principal Mezger provided a technology update.

Superintendent Meyerle reported on some floor work at the elementary school in the Art room and Boys' restroom. He also reported that this summer there would be some updates at the high school with new trophy cases with designated spots for athletics, All State athletes, FFA, Speech, etc. and an area for recent happenings. If anyone is interested in the old trophy case, by the old gym at the HS, they should contact Superintendent Meyerle. He also noted that athletic record boards will be mounted in the link to the new gym. The records are currently on a touch screen, and are not really visible. Motion to approve the use of the Special

Building Fund for elementary entrance renovations for safety and security made by Adam Engelman and seconded by Kasey Murphy. Motion passed with 5 yea, 0 nay. The Board agreed with noted concerns and looks forward to the update to the entrance of the elementary building. The update will be scheduled to take place in the summer of 2025

Superintendent Meyerle noted the 2022-2023 Annual Report is available on the school website. He also reported that he was pleased where the district stood financially at this point of the year compared to the last couple years. Reduced spending and the elimination of two classified positions helped a great deal. Motion to approve bills as presented made by Kasey Murphy and seconded by Paul Kostal. Motion passed with 5 yea and 0 nay.

Kasey Murphy had a question on the bills from ESU 5 and a pay rate. Superintendent Meyerle will contact ESU 5 to clarify. Superintendent Meyerle reported that he had registrations set for all Board members at the NRCSA conference in March in Kearney.

# How Can We Speak About God?

If someone were to ask you, "Who is God?" what would you answer? You might stammer a little and then say, "Well, God is...God." After a moment of reflection, you could quote I John 4:16 and say that God is love. As you kept thinking about it, you would find much to say: God is all good, God is all-knowing, God is all-merciful, God is just, God is infinite, God is all-powerful, God is everywhere.

One of my friends while in seminary was asked in an oral exam about the mysteries of God, and why all of these mysteries are true. His simple response (for which he received a very good grade) was, "Because God said so."

The famous philosopher of the 17<sup>th</sup> century, Blaise Pascal, once said that something incomprehensible is not for that reason less real. We believe that man is made in the image and likeness of God. Yet, for the ways in which we speak of similarity between us creatures and our Creator, there is always a greater dissimilarity. Thomas Aquinas from the 13<sup>th</sup> century states that "concerning God, we cannot grasp what he is, but only what he is not, and how other beings stand in relation to him."

Even for us who are believers, we acknowledge the ability of human reason to know God. This makes us confident to dialogue about God with people of other world religions, with science and philosophy, as well as with unbelievers and atheists.

When I am teaching young children about God, they are amazed to learn that God is uncreated. God simply is. God never began to exist, he simply always was. God will never cease to exist. Our language about him is limited because we can name God only by taking creatures as our starting point. Since all creatures have a beginning and an end, it can be difficult to fathom that God was, is, and always will be.

All creatures are made perfectly how God wants them to be. From the lovability of your household cat or dog, to the grandeur of a lion in the wild, creatures resemble God in their truth, their goodness, and their beauty. In chapter 13 of the Book of Wisdom, it beautifully states that "from the greatness and beauty of created things comes a corresponding perception of their Creator".

Since God is infinitely simple, our human words always fall short in speaking of the mystery of God. Our belief in God is rooted in the gift of faith, and it makes me think of this quotation from one of my favorite movies: for those who believe, no explanation is necessary; for those who do not believe, no explanation is possible.

- -2 large carrots, chopped
- -2 celery stalks, chopped
- —I onion, quartered
- -3 garlic cloves, smashed
- —I parsnip, chopped
- —Handful of fresh parsley
- —I bay leaf
- —Salt and pepper to taste
- —12 cups of water

### Instructions:

- Combine all the ingredients in a large pot
- Bring the mixture to a boil, then reduce the heat and let it simmer for about 1-2 hours.
- Strain the stock to remove solid pieces.
- Allow the vegetable stock to cool before transferring it into canning

- Sterilize your canning jars and lids
- Ladle the cooled vegetable sock into the jars, leaving about an inch of headspace.
- Wipe the jar rims with a clean, damp cloth to ensure a proper seal.
- Place the sterilized lids on the jars and screw on the metal bands until fingertip-tight
- Process the jars in a boiling water bath for the recommended time for your altitude.
